- a. Is not residing in New Zealand; or**
- b. Is of unsound mind, is a person in respect of whose affairs an order under the Protection of Personal and Property Rights Act 1988 is made, or otherwise is unfit or unable to act as a Board Member; or**
- c. Is or becomes a bankrupt who has not obtained a final order of discharge, or whose order of discharge has been suspended for a term not yet expired, or is subject to a condition not yet fulfilled; or**
- d. Is or has ever been convicted of an offence involving dishonesty as defined in section 2(1) of the Crimes Act 1961, or an offence under section 373(4) of the Companies Act 1993 (unless that person is an “eligible person” for the purposes of the Criminal Records (Clean Slate) Act 2004); or**
- e. Is an individual who is prohibited from being a director or promoter of, or being concerned or taking part in the management of, an incorporated or unincorporated body under the Companies Act 1993, the Securities Act 1978, the Securities Markets 1988, or the Takeovers Act 1993; or**
- f. Is disqualified from being an officer of a charitable entity by section 16(2) of the Charities Act 2005**
